- Supported negotiations for Zoom's 2022 Data Protection Impact Assessment removing 9 high privacy risks from initial 2021 DPIA – led the development and implementation of enterprise-wide data retention and deletion policy and standards for 100+ services and microservices.
- Spearheaded a Data Standards Implementation Pilot & Framework - established to develop USCIS data standards and governance to support cross functional business groups and other internal groups.
- Developed USCIS Agency Wide CDO Data Quality Issues Framework and the FY21 Data Governance Framework – operationalizing data quality and standards testing and monitoring for 50+ systems and 200+ data elements.
